The call for applications is open from the 11th of March 2024 to the 23rd of June 2024.

To be valid the application must be

- Submitted in English.
- Fully completed (all the questions are required).
- Signed by the official representative of the entity who applied.
- Transmitted before the 23rd of June 2024 at midnight.

Submission process

Applications should be submitted in English by the organization(s), port and/or local or regional authorities, who is/are entitled to represent the project.

Submission files should be sent by email to submission@aivp-rufenacht-prize.org.

Applicants should indicate in the subject line of the e-mail: *AIVP Prize – submission – name of the entity who applied*.
